### Statue of Unity Project

Request for Expression of Interest

Govt. of Gujarat through Sardar Sarovar Narmada Nigam Limited (SSNNL) is implementing the Statue of Unity Project in Memory of *Shri Sardar Vallabhbhai Patel*, on Sadhu Island on the downstream of Sardar Sarovar Dam at Kevadia in the District of Narmada in the State of Gujarat. The Project comprises of construction of a 182 Meter tall statue of Shri Sardar Vallabhbhai Patel along with Viewer's Gallery, exhibition Centre, Admin cum Hotel Building, Road connecting the Sadhu Island to the Main Land at Kevadia. The cost of the Project is **Rs. 2989 Crores**. The Project period is 42 months.

SSNNL has awarded a Design Build and Operation & Maintenance contract for the said Project. The Project involves architectural, civil, structural engineering and electro mechanical engineering designs. The design and drawing shall be provided by the EPC contractor.

SSNNL intends to appoint a **"Proof Consultant"** for scrutiny, vetting and recommendations for approval of the detailed engineering designs prepared and submitted by the EPC contractor. SSNNL invites **"Expression of Interest"** from reputed and experienced consultants having experience and expertise of scrutinizing, vetting and making recommendations for approval of the civil, architectural, structural and electro mechanical engineering designs and drawings.

The experienced and expert consultants shall have standing and experience of at least 10 years in the field of formulation of detailed engineering design and construction drawings, vetting and approval of engineering designs and drawings based on Indian/American/ British Standards (as applicable) in the fields of civil, architectural, structural, electro mechanical engineering. Consultants having a minimum financial turnover of at least Rs. 50 Crores (\$ 10 million) in any two of the last 10 Financial Year and experience in providing services as a **"Proof Consultant"** for a major tall and iconic building /structure situated in similar climatic conditions as that of proposed Statue of Unity having (i) minimum height of 180m, (ii) public spaces minimum up to 150m height, (iii) shall be in use since at least last 5 years, (iv) provided services in at least one EPC mode Contract in the last 5 years, (v) footprint of minimum 30,000 people/month, covering architectural, civil, mechanical, electrical, exterior cladding and sculpting services for at least one project costing Rs. 750 Crores (\$ 150 million) are requested to submit their "Expression of Interest" to the Chief Engineer, Central Procurement Cell, SSNNL, 6<sup>th</sup> floor, Block No. 12, New Sachivalaya, Gandhinagar 382 010, Gujarat, India on or before **15<sup>th</sup> December 2014**. The "Expression of Interest" shall comprise of the consultant's Company Profile, Professional Staff with Qualification and Experience, Overall and available locally, details regarding public spaces consultants/experts, experience in metallurgy, disaster management, Projects for which proof consultancy is provided with the names and addresses of the Client, Financial Statement and Technical Capabilities to provide similar services.

Joint Venture (JV) Consortium between a maximum of two members will be permitted. One may be a foreign member but not having more than 49% stake.
